

### Effect of GDP changes on road traffic fatalities 2013



A paper titled 'Effect of GDP changes on road traffic fatalities' co-authored by George Yannis, Eleonora Papadimitriou and Katerina Folla is now published in the Journal of Safety Science. This research aims to associate annual Gross Domestic Product (GDP) changes with the related annual changes in road traffic mortality rates. Mortality rates and GDP per capita data for the period 1975-2011 are used from 27 European countries, for the development of mixed linear models. The results suggest that an annual increase of GDP per capita leads to an annual increase of mortality rates, whereas an annual decrease of GDP per capita leads to an annual decrease of mortality rates. These effects are statistically significant overall, and in different groups

of countries (Northern/Western, Central/Eastern and Southern). A one-year lagged effect of annual GDP decrease was found to be significant in Northern/Western countries. DOI>

## ETSC Lecture - Road Safety, Reliable Data, Effective Policies, Berlin

The 15th European Transport Safety Lecture was organised by the European Transport Safety Council (ETSC) together with its three founding members the German Road Safety Council, the Dutch Safety Board and the British Parliamentary Advisory Council for Transport Safety and took place with great success on November 21st, 2013 in Berlin. Prof. Dietmar Otte from the Medical University of Hannover gave the Lecture on Road Safety: Reliable Data - Effective Policies, having attracted a large audience of more than 150 national and international road safety practitioners, technical specialists and decision makers. Response to the Lecture was given by European Commission Head of Road Safety Unit Mr. Szabolcs Schmidt and TU Delft Professor Fred Wegman. At the lecture and the vivid discussion followed there was

focus to the need for reliable and accurate data to be placed at the core of road safety policies, serving to identify problems, risk factors, and priority areas as well as to formulate strategies, setting targets and monitor performance. LINK

This ETSC Lecture coincided with the celebration of 20 years of ETSC. On the occasion, ETSC Chairman Herman De Croo stated that "ETSC has marked 20 years of concerted advocacy efforts on road safety throughout Europe, acting as an established source of independent and impartial advice to policy and decision-makers in Europe". ### RACC - Reducing road accident victims in urban areas Conference, Barcelona 2013



The 20th Forum for Road Safety 'Reducing victims of road accidents in urban areas', organised by RACC, P(A)T and Generalitat de Catalunya took place with the participation of more than 200 road safety experts, decision makers and stakeholders, in Barcelona on 14 November 2013. The conference focused on a range of preventive, and corrective techniques applied to the management of public space, especially in the locations in which more accident and fatalities occur as well on the

safety of vulnerable road users. Urban Authorities presented and discussed the complexity of implementing measures addressing and balancing safety concerns of the various different vulnerable road users. LINK

This Conference brought together the most important stakeholders, experts and public authorities from the South-Eastern Europe region who are engaged in road safety. The aim of the conference was to promote road safety in South East European

roads through standardised safety assessment of the road infrastructure, proposals for road safety investments, comparative evaluation of safety performance and user behaviour in SEE countries and the active promotion of safer road user behaviours. LINK

## EU Cross-Border Enforcement Directive 2013



The Cross-Border Enforcement Directive (2011/82/EU) of the European Commission, is now in force since November 7th, 2013. This Directive enables that EU drivers are identified and thus prosecuted for offences committed in a Member State other than the one where their vehicle is registered. EU Member States will exchange information on drivers who commit traffic offences abroad, including the four

"big killers" that cause 75% of road fatalities - speeding, running traffic lights, failure to use seatbelts and drink driving. This information exchange will ensure that foreign offenders can be pursued and punished across borders. The Directive targets traffic offences with a critical impact on road safety,

Speeding or failing to stop at traffic lights,

Driving under the influence alcohol or drugs,

 Failing to wear a seatbelt or a safety helmet (for motorcyclists), Illegal use of mobile phone while driving or of an emergency lane.

## WHO Interactive map of traffic death rate 2010



The World Health Organization (WHO) launched a map based interactive tool with the estimated traffic death rate (per 100.000 population) for each country. This tool offers to the user the option to select the estimated traffic death rates by country, by region and for different income levels. LINK

## BASt - Ageing and Safe Mobility Conference, Bergisch-Gladbach 2014



An International Conference on Ageing and safe mobility, organised by the Federal Highway Research Institute (BASt), the Forum of the European Road Safety Research Institutes (FERSI), the European Conference of Transport Research Institutes (ECTRI), the European Transport Research Alliance (ETRA), the European New Car Assessment Programme (Euro NCAP), the Forum of European National Highway Research Laboratories (FEHRL) and the Human Centred Design for Information Society Technologies Network (HUMANIST) will take place in Bergisch-Gladbach, on 27-28

November 2014. The abstract submission closing date is set to 15 January 2014. The Conference will focus on the road safety problems of elderly road users and it will aim at elaborating policy recommendations concerning implementation of available road safety evidence based research results. The four sections of the Conference are: Human Factors, Infrastructure, Vehicles engineering, Traffic Management Systems. LINK

The World Day of Remembrance for Road Traffic Victims is observed on the third Sunday of November each year (this year on 17 November 2013) by an increasing number of countries on every continent around the world. This day adopted by the UN in 2005, is dedicated to remembering the many millions killed or injured in road crashes and their families and communities, as well as to pay tribute to the dedicated emergency crews, police and medical professionals who daily deal with the traumatic aftermath of road death and injury.

In Greece this year, Efthita Rhodes and SOS Traffic Crimes, members of FEVR (European Federation of Road Traffic Victims) and the Global Alliance of NGOs

for Road Safety, organised a series of events to commemorate this day LINK, including the promotion of the special video translated in several languages. UNK
