#### EU Reports second good year in a row 2013



The European Commission has published the most recent statistics on road fatalities, based on provisional data for 2013 showing that road fatalities across the EU have decreased by 8% in 2013. This reduction, following the reduction of 9% in 2012, means that Member States are back on track towards the strategic target to reduce the number of road deaths on Europe's roads by half in 10 years (2011-

Country by country statistics show that the number of road deaths still varies greatly across the EU, from around 30 (Sweden, UK, Denmark and the Netherlands) to more

than 80 (Romania, Poland, Croatia, Latvia, Lithuania, Bulgaria and Greece) deaths per million inhabitants. LINK In the respective accompanying European Commission Road Safety Vademecum, the basic safety trends,

The Transport Research Arena 2014 (TRA 2014) took place with great success in Paris on 14-17 April 2014. TRA 2014 is the major conference on transport research in Europe , organised by IFSTTAR , the French Institute of Science and Technology for Transport, Development and Networks, supported by the European Commission, the Conference of European Road Directors, and the three European Technology

Platforms: the European Road Transport Research Advisory Council (ERTRAC), the European Rail Research Advisory Council (ERRAC), and the Waterborne TP. LINK

Almost 3,000 participants from 56 countries attended over 130 sessions, 650 presentations and 15 associated events. Bernard Jacob, IFSTTAR Deputy Scientific Director, stated that researchers and industrial and public policy players had vivid discussions on our society's changing transport usage and requirements in the face of increasingly serious energy and environmental challenges. Current and future road safety challenges were discussed in several sessions, including the Transport Safety strategic session chaired by NTUA Associate Professor George Yannis, NTUA presentations concerned:

- Transport Safety in Europe a cross modal approach European perspectives for reliable crash modification factors
- Development of the European Road Safety Knowledge System
- Analysis of road safety management systems in Europe
- European Road Safety and e-Safety
- Assessment of road safety legislation, policy and institutional capacity in South-East European regions The First exploration of the effect of road environment on distracted driving through a driving simulator
- The First findings from a simulator study on driving behaviour of drivers with cerebral diseases
- Attitudes of Greek drivers towards mobile phone use while driving Mobility and safety of powered two-wheelers in the OECD countries

#### Dacota paper awarded best poster presentation at TRA 2014



A paper based on the results of the DaCoTA research project has been awarded the best poster of scientific paper award of the Transport Research Arena Conference . This paper was presented by NTUA Associate Professor George Yannis and concerned the "Development of the European Road Safety Knowledge System", published at the Proceedings of the Transport Research Arena Conference, Paris, April 2014. The objective of this paper was the presentation of the integrated and

comprehensive European Road Safety Knowledge System, which was developed within the DaCoTA research project of the 7th Framework Programme of the European Commission 👼 📭.

The Civil Engineering School of the National Technical University of Athens was ranked 28th among all Civil Engineering Schools worldwide and 7th in Europe . ### ROSEE - Transnational Road Safety Workshop, Budapest 2014



The Transnational Road Safety Workshop took place in Budapest, on April 9th, 2014 and was organised by the ROSEE project in the framework of the South East Europe transnational cooperation programme. Representatives from the ROSEE project countries (Italy, Romania, Hungary, Greece, Slovenia, Bulgaria) discussed on the

current road safety situation in the South-East European regions, explored the potential for the improvement of the road users' and the road infrastructure safety and contributed in forming proposals and recommendations for road safety investments. 
### ETSC - 12.000 car occupant fatalities in EU in 2012



In April 2014, the European transport Safety Council (ETSC) published in its redesigned website a PIN Flash concerning Car Occupant Safety. Around 240,000 car occupants were killed in road collisions in the EU in the years 2001-2012. There were 12,345 deaths in 2012 compared with 27,700 in 2001, a cut of 55%. Deaths of car occupants were cut by more than the overall death rate (49%) and

substantially more than the rate for other road users (41%). Car occupants have therefore benefitted more than other road users from road safety measures adopted over the past decade. This is not surprising, as many of those measures were targeted at car occupants including increased enforcement of the main traffic offences, improved vehicle occupant protection, and, to a lesser extent, improved infrastructure. #### Relationship between motorcyclists' attitudes, behaviour and other attributes with declared accident involvement in Europe - 2014



A paper titled 'Relationship between motorcyclists' attitudes, behaviour and other attributes with declared accident involvement in Europe' co-authored by Athanasios Theofilatos and George Yannis is now published in Traffic Injury Prevention. The objective of this study is to investigate patterns of road safety attitudes and behaviors of motorcyclists in Europe on the basis of the results of the pan-European questionnaire-based survey SARTRE-4, carried out in late 2010 in 18 European countries and Israel. It was found that motorcyclists who tend to have dangerous attitudes and behaviors as well as younger motorcyclists are more likely to have been involved in an accident. The findings of the study

provide some insight into the association between attitudes, behaviors, and declared past accident involvement. DOI>

## Sixth European Road Safety Day - Athens 2014



The Sixth European Road Safety Day will take place in Athens on May 9th, 2014 organised by the European Commission, in cooperation with the Greek EU Presidency. This one-day conference, centred around the headline theme Safe and smart infrastructure, will bring together road safety experts, stakeholders and decisionmakers and give them the opportunity to share their knowledge and discuss ways to continue improving European road safety.
